Food Access activities made up the largest portion of the FY2017 budget in terms of expenses. In FY2017, COPE continued to work with a coalition of multi-sectorial individuals and organizations to promote access to healthy food on Navajo Nation. We worked with growers and stores to increase access to healthy foods on Navajo Nation and implemented a "Fruits and Vegetables Prescription" Program to help families purchase fruits and vegetables from local retailers.

4b (Code:) (Expenses \$ **412,094** including grants of \$) (Revenue \$ **69,741**)

Training and Outreach activities made up the second largest portion of the FY2017 budget in terms of expenses. Training and outreach activities included development of patient education materials as well as numerous training activities across Navajo Nation. COPE also provided educational materials including flipcharts, patient incentives, and materials for food demonstrations to healthcare providers to use with their patients.

4c (Code:) (Expenses \$ **134,125** including grants of \$) (Revenue \$)

Program Evaluation and Partnership Activities in FY2017 comprised the third largest portion of the FY2017 budget in terms of expenses. Program Evaluation focused on evaluating the impact of Training and Outreach and Food Access Services. COPE analyzed outcomes of individuals participating in the Fruit and Vegetable Prescription Program, the impact of the Healthy Navajo Stores Initiative, and the lessons learned of forming inter-professional teams. Partnership activities included programs for promoting youth leadership and activities to support strong coalition-based participation among community members and diverse stakeholders.

Included in the in-kind contributions totaling \$1,296,663 is contributed services valued at \$793,454 which are not included in this Form 990 due to not meeting Internal Revenue Service criteria for inclusion.

PIH was the direct employer of persons who performed work for COPE until February 2017 when COPE became the employer. Although PIH was the employer for a portion of the fiscal year, the Board of Directors of COPE did not delegate control of any management duties that would customarily be performed by or under the direct supervision of COPE's officers, directors or key employees.
